Awards, Honors and Recognition**Superintendent Dr. Ralph Marino recognized the following honors and achievements:**

- Middle School Family and Consumer Science Teachers Sue Carney and Elisha Mashanic for their work in helping students acquire skills in interviewing, resume-writing and preparing for a job. Each eighth-grader in FACS classes prepared a resume and job application before being interviewed. District staff, parents and businesspeople conducted the interviews. Afterward, each student wrote their interviewer a thank-you note using the feedback given to them.
- Sixty-five Choral Students from the Middle School will perform at the Clemens Center Annual Holiday Concert on December 9th at 4 PM. The group was chosen to sing with the Orchestra of the Southern Finger Lakes.
- Three High School Music Students – Kate Nicole Hoffman, Patrick Leslie and Michelle Li – have earned acceptance to the prestigious National Association for Music Education(NAfME) Eastern Division Honor Ensembles. Kate Nicole, a senior, has been selected to the All—Eastern Choir. Michelle, also a senior, has been selected for the All-Eastern Concert Band, and Patrick, a junior, has been chosen for the All-Eastern Jazz Ensemble. All three students earned perfect scores on Level 6 Solos—the highest level of difficulty.
- Middle School Students Mackenzie Bailey, Adrienne Bacon, Brianna Henry, Alison Eustace and Grace Seeley coordinated the “Clothing Craze.” They gathered gently used clothes from students and staff and organized them to be swapped/recycled to parents or students. Remaining clothes were bagged up and donated. The students worked every day for weeks during their free time to make the “Clothing Craze” happen.
- Thirty High School National Honor Society Students helped out at the Silent Auction to benefit the Arnot Ogden NICU at the Wings of Eagles Discovery Center November 8th. They helped set up for the function, serve the food and clean-up afterward. Some 330 people attended.
- Seniors Melissa Dubots and Sean Bassler were accepted to the prestigious New York State Band Directors Association Senior Honor Band in Liverpool from March 1st – 3rd. Melissa plays alto saxophone and Sean plays trumpet.
- The Chemung Valley Soccer Officials Association awarded the Wilson Award to the Boys Varsity Soccer Team and Coach Mark Mucci were selected to receive the award, which is given to the boys and girls coach and team that has exhibited the highest level of sportsmanship during the season.
- Students who participated in the Area All-State Festival in October achieved Zone 15’s highest accomplishment. They are considered the best in the zone, a five county area, as reported by NYSSMA Zone 15 Representative John David Vona in a letter to Board President Brian Lynch.
