Agenda Changes

Board President Jim Jacobus welcomed everyone to the last Business Meeting of the school year and stated there are no Agenda changes; however, there will be an Executive Session directly after the Board Meeting to discuss CSE/CPSE/504 Recommendations, the Board's Self-Evaluation and an Extension of the Superintendent's Contract.

Community Questions and Comments

There were no questions or comments from the Community.

Student Representative Report

Student Representative Sruti Akula stated that the school year has slowed down a little since the last day of classes on June 13th, with Graduation being held this Saturday, June 25th. Sruti thanked the Board for this wonderful opportunity she had as a member of the Board this past year. Sruti stated it was an honor to serve on the Board, to see the behind the scenes of what it takes to run a school district so smoothly and stated it is an honor to be part of the Horseheads School District. Board President Jim Jacobus presented Sruti a Certificate of Appreciation for being the Student Representative this year.

Presentations

Introduction of New Student Representative and Alternate To The Board Of Education For the 2016-2017 School Year

High School Principal Karen Donahue introduced Matthew Minor and Camden Layton(Student Alternate) who will be the new Student Representatives to the Board of Education starting July

1, 2016. Karen stated she is delighted to have them represent the High School and know they will do a fabulous job on the Board.

Data Center Update

Assistant Director of Elementary and Secondary Education Shawn McDonough shared the District's Data Center, which has been updated with the newest State Data(2014-2015 school year). Shawn also shared the School Report Card site on the New York State Education Department's Website. Shawn stated the data is readily available, transparent on the District Website under Data Center Home and stated a new tab, Special Education Data and Enrollment Data, was added. Shawn emphasized the State has put charts on the site that are interactive.

Board Member Brian Lynch thanked Shawn for presenting a great overview of the Data Center. Brian stated it is important for the data to be on the Website in case people want to move to the District so that they are able to readily access it and for those who currently are in the District as they are able to use it to compare to other districts. Brian stated the new format looks tremendous and thanked Shawn and the BOCES Team for keeping it on target and up to date.

Student/Staff Wellness and Safety Update

Director of Human Resources Judy Christiansen presented the 2015-2016 Annual Wellness Report to the Board for information only. Judy stated the Student Wellness Report is presented pursuant to Board of Education Policy 5405 and focuses on Student Wellness in three main areas: Nutrition, Physical Activity and Other Activities. Judy stated that there have not been any new initiatives from the Federal Government since 2014 and noted that we are in compliance with all guidelines. Judy stated the District-Wide Safety Plan has been modified, we are trying to put together an Intruder Drill to be held on the October Conference Day and Journey Fitness has offered a Corporate Staff Wellness Challenge from October 10-31, 2016.

Superintendent Report

Superintendent of Schools Dr. Thomas J. Douglas stated that the school year is ending with a wonderful celebration for the staff which is currently being held at the Elks Club with over 200 in attendance. Dr. Douglas congratulated everyone for an outstanding year, especially during difficult economic times.

Excellence in Teaching Award Recipients

Superintendent of Schools Dr. Thomas J. Douglas shared with the Board the great news that two District teachers were awarded the Empire State Excellence in Teaching Award (sponsored by Governor Cuomo): Ridge Road Second Grade Teacher Nichole Inthanongsak and Gardner Road Fourth Grade Teacher Elisabeth Bostwick. The two were surprised with the awards this week and both received a \$5,000 stipend from the State. Dr. Douglas commended them for such a great job.

PERMA Safety Person of the Year

Superintendent of Schools Dr. Thomas J. Douglas recognized Director of Facilities Mike Coghlan who was named PERMA's Safety Person of the Year this year. The Board viewed a video shown at the recent PERMA conference, where Mike officially received the award. PERMA, or Public Employees Risk Management Association, is the District's Workers' Compensation. Dr. Douglas stated that Mike certainly did the District proud and stated that Mike is a very active person and strives to continue to keep our District staff and students safe.

Boys' Volleyball Team

Superintendent of Schools Dr. Thomas J. Douglas updated the Board on the status of the Boys' Volleyball Team, noting that we have about 15 boys who want to continue on, but we only had one applicant in the first round who had no experience and very little knowledge of volleyball and there was no internal interest. After broadening our search, the second time around, we have three applicants, however, only one of the three have coaching experience. We have a two-week window before the Organizational Meeting and we are trying to address the situation as best as we can. However, if we don't have a coach, there will be no Program because we have to develop a schedule which has to be done by the Coach. We are going to proceed cautiously with July 1st as a deadline.

Superintendent of Schools Dr. Thomas J. Douglas brought to the Board's attention that Board Member David Sadler inquired if we could pull Item 11.20 – Revised Policy 2250: Board Committees from tonight's Agenda so that further discussion could take place. Dr. Douglas stated that this Policy was really developed by the Board at its' Board Retreat and it is not for him to pull it. Dr. Douglas noted at this point there will be a second reading and Board action later this evening as a follow-up to the May 26th Board Meeting per the Board's request to revise the language which Dr. Douglas and Doug Johnson did.

Superintendent of Schools Dr. Thomas J. Douglas stated that at the end of the calendar year we have the Board Change Over and presented Board President Jim Jacobus with four books in Jim's name to be part of the library collections in our schools. Dr. Douglas presented the books to Jim, sharing the meaning behind the choices. Several Board Members praised Jim for his service to the District, and his advocacy for children and education, both as a member of the Board for 12 years, and as a District Teacher for 32 years. The Board shared their thanks and good wishes to Board President Jim Jacobus, who decided to enjoy another 'retirement' as he chose not to run for re-election this year.

Board President Jim Jacobus presented fellow Board Member Pam Strollo with a NYSSBA Board Achievement Award Certificate for professional development(75 points).

Pam noted the Committee heard several presentations, noting that Julie Kephart presented the 2015-2016 Student Services and Data Internal Audit Report, which is the area the Committee chose for our Audit for this year. Katy Buzzetti presented the 2015-2016 Risk Assessment Update Corrective Action Plan and the 2015-2016 Student Services and Data Internal Audit Correction Action Plan which will be presented later this evening for Board action and Tom Zuber reviewed preparation for the 2015-2016 External Audit and discussed changes to State Regulations that will come into effect in the 2018 timeframe.

Superintendent of Schools Dr. Thomas J. Douglas informed the Board that he was just notified that the Audit Committee will need to hold a meeting between now and July 1st due to an item that the District has to respond to. Dr. Douglas emphasized that this cannot wait for the Committee to be appointed at the August Meeting and stated overall the Audit will not change. We need to sit down and share information with the Committee to see if there is anything the Committee wants in the response. Dr. Douglas stated we are asking for our External Auditors, attorney and Katy Buzzetti to make the response and noted that Katy Buzzetti will schedule the meeting for next week.

Finance Committee

Board Member David Sadler reported on the June 13, 2016, meeting of the Finance Committee. David noted that we have two High School Extra-Classroom Accounts that basically do the same thing, therefore, we are going to combine them. Pam stated the Committee reviewed the Human Resources Recommendations which will be presented later this evening for Board action and also reviewed the claims and contributions which are relative to the Health Insurance Plan.
