Presentations

Center Street PTO Update

PTO President Stacey Huftalen, shared the PTO's continual involvement at Center Street Elementary School. The PTO recently helped purchase books for the Site Base Team which will increase their knowledge which will directly impact the students. The PTO also financially helped to support teachers who attended a workshop in New York City and sponsor special assemblies for the School. Stacey stated the PTO also created new character education teaming games for the Fall Festival, sponsored the Food Drive, Family Nights and many, many more activities and requests thoughtout the year.

Center Street School Presentation: "Teaching For Tomorrow....Today"

Center Street staff and students shared their message of how the school staff is "Teaching For Tomorrow.....Today." Center Street Principal Patty Sotero and students from the Sign Language Club welcomed Superintendent Dr. Ralph Marino and the Board to Center Street Elementary School verbally and through the use of Sign Language.

Third Grade Teacher Elizabeth Sutton showed a video about 21st Century Learning and purposeful writing. The video showed a Skype session students had with Dr. John Sutton, Technical Writer for General Electric, and Jennifer Sotero Batt, Senior Engineer. They talked with the students about the importance of writing, revising and adding details. Elizabeth stated this was a unique experience for the students as they were able to interact with people who are 3,000 miles away. The Site Base Team thought it would be beneficial for the students to learn how important it is to become good; strong leaders.

Special Education Teacher Kristen Miller reported that ten staff members volunteered two Saturdays to attend a free writing conference in October and is currently sharing what they learned with their colleagues at Staff Meetings. Kristen stated that they have heard colleagues make statements such as, "How jealous they are that they didn't go to the conference and hope that they are able to go next year." Kristen stated the staff at Center Street Elementary School are committed to learning more and have been reminded to go back to what our vision is and how do we get our vision to be viable in our school. Kristen stated we are teaching our writers viable skills today for tomorrow.

Second Grade Teacher Shelby Lese shared the book, "Essential Question, Opening Doors to Student Understanding," that the Site Base Team is currently reading. Shelby described the Terrific Writers Program and stated that a Committee was formed who will determine specific writing skills that may be addressed at each grade level. The staff will strive to implement best practices in the classroom with two Webinars having been planned for the staff.

First Grade Teacher Sarah Potter described the various School Clubs including Homework, Sign Language(18 members), Yearbook(16 members) and Newspaper Club(13 members). Students handed out the recently printed first edition of the "Center Street Times." Also, throughout the presentation, students took photos for the school yearbook.

First Grade Teacher Kate Williams and Third Grade Teacher Kelli French shared their love for teaching writing and all the positive teaming going on throughout the building in Grades 1, 3 and 4. Kate stated that the teachers are team teaching specific areas that they specialize in such as she is in the area of writing. Kate stated she is using the Writers' Workshop where students share their reading/writing in the Author Chair. Kelli reported that one teacher concentrates on ELA and the other teacher on Math and Science which allows the teachers to focus on subjects that they are most passionate about which will create better student outcomes.

Student Council Advisor Lorraine Packard presented the Student Council Officers, who shared information about what they do and the many activities they lead such as School Spirit Days, Breast Cancer, Salute Our Veterans, Toddlers for Tears Project, March For Hunger, Holiday Cards For Heroes and more.

Kindergarten Teacher Terri Standish highlighted the Character Education Program and its activities, including Filling Students' Buckets and the "I can" focus. Terri stated that "I Can" statements include "I can be anything I want to be when I grow up as I am learning at Center Street"

Physical Education Teacher Jennifer Bryant showed a video clip of the school's morning news show, "WCSN News."

Principal Patty Sotero closed the presentation stating that tonight Superintendent Dr. Ralph Marino, the Board and Public heard many of the exciting learning activities that take place at Center Street Elementary School and will leave tonight knowing as she does that Center Street Elementary School has an exceptional staff who will do everything that is necessary in order for the students to meet their potential in life.

Board President Brian Lynch thanked Principal Patty Sotero, the Staff, Student Council Members and the PTO President for presenting an amazing presentation. Brian stated that this is his 9th year on the Board and he is always wondering how Center Street can out do itself year after year, but they always do. Brian stated it is very obvious that the entire school population is committed on the focus of preparing the students for the future, by "Teaching For Tomorrow....Today." It is wonderful to hear that the staff is teaching outside of the box through the use of Skyping and that the staff is also focusing in the areas of reading and writing which are very important as the skills taught will be used throughout the child's lifetime. Brian stated that the various Clubs that are provided to the students along with the Student Bucket Program really help build the student's confidence and that the PTO has done an amazing job supporting the staff and students through the use of sponsoring various activities; Brian stated that the financial support the PTO provides to the school is tremendous as they continue to support teacher conferences, field trips, supplies and other requests as presented. Brian thanked Principal Patty Sotero, the staff and the PTO for all of the time, the dedication and the great job they are doing educating the students at Center Street Elementary School.

Board Member Karen Boulas echoed Brian's comments and also stated that she can really feel the enjoyment, the dedication and the pride that the staff, students and parents have for their school. Karen stated that she is very proud of them.

Board Vice-President Pam Strollo thanked the staff, students and parents for attending tonight's presentation and stated that tonight we were shown that Center Street Elementary School is truly a school community that consists of staff, students and parents who make the school a great place to be and throughout tonight's presentation the evidence of how much everyone cares about the school and the students was shown.

Board Member Doug Johnson also thanked the staff, students and parents for coming out tonight and providing the Board with such a great presentation.

Superintendent Dr. Ralph Marino also echoed the sentiments that were made by the Board and thanked the staff, students and parents for their commitment to Center Street Elementary School and making it a great place to be.

Thailand Summer Exchange Experience

English as a Second Language Teacher Cindi DeRichie shared her experiences abroad as part of the Thailand Summer Exchange Program. Cindi stated that this past year she had the wonderful experience to participate in the Thailand Educator Exchange Program with Sudara(Tuck Tick) Sakkaamduang who visited our country last October for 2 ½ weeks and this past summer Cindi was able to visit Tick's country and experience their educational system and learn about their culture. Cindi stated that her visit also helped to strengthen the leadership between the countries so that we can better understand each other. Cindi stated that Thailand's education system is very similar to ours; it is all public and paid for by the government. There are three levels—Level 1 – KGI-KG3, Level 2 – Primary – 6 yrs. – 11 yrs and Level 3 – 12 yrs. to 18 yrs. One of the goals of the education system is for the students to be proficient in English by the time they graduate. Religion is very ingrained in the education of the students. Cindi stated that she really learned a lot through this Exchange Program as she not only experienced the culture, customs, education, and religion but also attended a School Board Meeting with State Education Department members present. Cindi stated that Thailand doesn't have the Common Core or APPR, instead they really believe that the people

come first and other things will fall into place. Cindi stated this is a philosophy that she will put to use in her lessons.

Board President Brian Lynch thanked Cindi for a wonderful presentation and for sharing her photos and experiences with the Board.

Review of the Community Focus Group's Work of October 26, 2013(Dr. Paul Seversky and Mr. Jeff Robbins)

Dr. Paul Seversky and Mr. Jeff Robbins presented the report from the October 26th Community Focus Group's Workshop. Paul stated that it has been a pleasure and honor to work with the District and that he admires and respects the Board for using their legal right to execute how to best serve the young people of the Horseheads community over the next three years. Paul stated that Jeff and he take very serious the role as guest(outsiders) and realize in the end the decisions that are made will be the right ones. Paul stated the Board did an excellent job with selecting the 64 people who came together for the Focus Group. Paul stated that it was obvious throughout the day they were people who represented the full Horseheads community; who worked very well together, listened to each other, discussed and identified other scenarios (which offered additional opportunities and challenges) that the Study may not have had represented in July. Paul stated it was very important that this group realized that they knew that they would not be making any recommendations, but would be ranking the order of scenarios that would best serve the students. The ranking was done individually so that no one's thoughts were lost. Everyone's perceptions, ideas and comments were documented. Initial Ranking Ordering was completed for all 16 scenarios and then the Top 8 were Ranked Ordered and sent to the Superintendent.

Mr. Jeff Robbins stated that he displayed floor plans of all the scenarios so that the people could get a feel of what it might look like. Jeff stated the Focus Group was very encouraged, asked questions, did not take this task lightly and really talked together to come up with the rank order that was presented. Jeff stated that as the Options are looked at more closely by the Board's Policy and Development Committee there will be challenges that will need to be considered involving buildings that may not be used, what is the integrity of each building, what would be the student population/grade level of the building served, the rationale used in selecting the building, etc.

Board President Brian Lynch thanked Dr. Paul Seversky and Mr. Jeff Robbins for their assistance in putting together the information and also the Members of the Focus Group for volunteering their time to participate in this massive effort. Brian stated that this document is a massive document which requires a lot of reading which is why he is not prepared to make a statement without fully digesting what is in it. Brian stated he appreciates the information, the letter that was sent, the details and the background information which is always helpful. The additional challenges noted are also very valuable. It is relevant, sound information that is crucial as we move forward.

Board Member Doug Johnson inquired if the information we received in the past(in the July study) regarding the estimated savings are still the same. Also, are the estimated annual savings long-term savings? Board President Brian Lynch stated that the construction cost in the July 11th book is still viable.

Consolidation Study Grant—Next Steps

Board President Brian Lynch stated that the Elmira Heights School District Consolidation Study Grant for \$49,500 was recently approved by the State. Brian stated that the two Districts met back in February and now that the Grant was approved we need to decide what the next steps are. Personally, Brian stated he would like to move forward and meet with the

Elmira Heights Board to see what the next steps are as it is a very long process and we need to understand what direction Elmira Heights wants to go in as well as Horseheads, if there are benefits, if we may need to accelerate the timeline, etc.

Board Member Mark Brinthaupt stated that it is an exceptionally good idea to move forward with it which is why he had inquired about the timeline and if there is a potential impact on the whole thing.

Superintendent Dr. Ralph Marino stated that the Elmira Heights Board will meet next week at which time preliminary discussions will be held regarding the timeline and what it entails. We have to have the conversation with Elmira Heights, map out an RFP as how to select a consultant, the attorneys will need to look at it to make sure we are all on the same page. Ralph stated that he anticipates a joint meeting will be held in January.

Board Vice-President Pam Strollo stated that given the unknown of when we are going to meet with Elmira Heights and when we can collectively come back with a recommendation relative to changing the timeline, maybe the Planning and Development Committee should look at developing another timeline to bring back to the Board. Board President Brian Lynch was in agreement with this comment.

Board Member Doug Johnson inquired if we will be missing another school year for possible implementation if we make adjustments to the timeline. Board President Brian Lynch stated that we don't know yet. We all want to go forward; however, we need to know all the information before we make any decisions. At the January Board Meeting, we could look at the new timeline the Planning and Development Committee submits which would push back the December 19th decisions due to this new possibility with Elmira Heights which could change the direction we choose to go in.

Board Member David Sadler inquired if we could move forward with both the Consolidation Grant and the work of the Focus Group. Board President Brian Lynch stated that this is absolutely an option.

Superintendent Dr. Ralph Marino stated that it is very important to know that Elmira Heights is the Lead Agency on this which means that Horseheads needs to follow their lead. Board President Brian Lynch stated that this could go to the voters as early as June if it is presented to the Board at the December 19th Board Meeting with a new timeline for the Board to discuss.
