**President's Remarks**

Board President Brian Lynch welcomed everyone to tonight's meeting. Brian stated this is the Board's third school visit and the Board really enjoys visiting the different schools and seeing the activities of what is going on in the schools and looks forwards to hearing the different schools' presentations as they are the highlight of the meeting. Brian reviewed the procedures for the Questions and Comments Section and reminded the Public to state their full name and address before commenting. Brian stated that Board Vice-President Pam Strollo was unable to attend tonight's meeting due to a conflict.

**Agenda Changes**

Board President Brian Lynch stated that Agenda Item 6.4 – Introduction of the new District Superintendent for the Greater Southern Tier BOCES, Jim Frame, will be added under "Presentations". Brian stated there will be an Executive Session directly after tonight's Regular Session to approve CSE/CPSE/504 Recommendations, discuss an update on Collective Negotiations(CSEA), discuss the employment history of a particular person and review the Superintendent's Mid-Year Goals.

**Questions and Comments from the Public**

There were no Questions or Comments from the Public.

**Awards, Honors and Recognition**

**Superintendent Dr. Ralph Marino recognized the following honors and achievements:**

- Sixth-grader Sophie Kartzman's final count for her Red Cross Holiday Mail for Heroes project was more than 9,200 cards which is very, very impressive.

- The Intermediate School collected 183 pairs of pajamas for the Scholastic Pajama Drive and Scholastic will match the donation with 183 books. All donations will go to local children in need.
- The Intermediate School Kids of Character for November were Alexa McPike, Grade 5, and Tyree Day, Grade 6.
- Gardner Road Elementary School students and staff raised \$265 for the Arctic League through a Coin Drive. The school's PTO matched the amount for a total donation of \$530, which a group of students brought to the Arctic League Telethon on December 7<sup>th</sup>.
- Gardner Road Physical Education Teacher Steve Monks will be inducted into the Chemung County Sports Hall of Fame on December 27<sup>th</sup>.
- Senior Jake Malloy is the High School's Daughters of the American Revolution Good Citizen. He earned the distinction through an essay he wrote on the spot and also won \$300.
- The High School collected more than 3,000 food items for the Horseheads Food Pantry during the Student Council Food Drive in November.

- Several district students participated in the USATF National Junior Olympic Cross Country Championships in Myrtle Beach Saturday. They competed against more than 400 other students in each of their age divisions from all over the country: seventh-graders Alissa French, Nathan Wilsoncroft and Alyssa Walker, eighth-graders Owen Juan and Dylan Kenyon, sixth-grader Evan Keister, Big Flats fourth-grader Samantha Oaks, Big Flats second-graders Tabitha Oakes and Anna Lowe.
- At the Elks Hoop Shoot on December 17<sup>th</sup> at the High School, several District students placed in their age groups:

- The Middle School Chapter of the National Junior Honor Society adopted two local families and bought and wrapped gifts for eight children through the Southside Community Center. The group also collected more than 50 hats and mittens and 100 coats for a local battered women's shelter.
- Nine fall sports teams earned Scholar-Athlete Team status by the New York State Public High School Athletic Association, meaning the required number of team members earned an average of 90 or higher during their sports season: Girls Cross Country – 98.64; Girls Tennis – 98.08; Boys Cross Country – 96.66; Girls Soccer – 95.76; Boys Soccer – 94.03; Girls Volleyball – 94.03; Gold – 92.98; Football – 92.86; and Boys Volleyball – 92.82.
- The Middle School collected 5,014 food items during their Student Council Food Drive.
- Members of the Middle School and Center Street Student Councils rang the Salvation Army Bell this holiday season. Gardner Road students will ring the Bell on Saturday.
- The Vietnam Veterans of America Chapter 803 and the Major Robert H Schuler Memorial Museum sent a letter to Center Street staff and students thanking them for their Veterans Tribute that was held on November 6<sup>th</sup>.

- During the last couple of weeks, the Corning Leader announced their All-Leader Teams for fall sports. Several Horseheads student-athletes have been named to the teams. Ralph stated this is very impressive.

## Presentations

### **Center Street Elementary School Presentation, "Learning Is An Active Sport: Let's Play!" and PTO Update**

Center Street Elementary School Principal Patti Sotero, students and staff members shared their message of how "Learning is an Active Sport: Let's Play!" Student Council members highlighted various opportunities for community outreaches they work on throughout the school year. The Student Council partners with the PTO sharing a successful "March Out Hunger Food Drive," Ring the Bell for the Red Kettle Drive at the Arnot Mall and recently formed a new partnership with the Red Cross. The Student Council and the Red Cross will be hosting several life-skill classes which will include teaching first aid, babysitting and how to respond to various needs at their age level.

Third Grade Teacher Kelli French updated the Board on Clubs that are offered after school such as Safety Patrol, WCSN which reports daily, Sign Language, Newspaper, Yearbook, Homework Club, with a record of 45 students participating this year, and a brand new Green Garden Club. Kelli stated that you may also see students participating in special events in the community such as singing at a Jackals' game.

Third Grade Teacher Stacey Finnerty shared how she turned her classroom into a Congress setting as students learned about the different levels of government, the Senate and the House of Representatives. The students were taught the process of writing a bill and having it either signed into law or vetoed by "President" Patti Sotero. Stacey stated this was a great experience for the students to learn hands-on the different levels of government and how the economy affects the passing of a bill into law.

First Grade Teacher Sarah Potter and students presented a project the fourth grade students did to solve a real-world problem. The students captured the joy in discovering, observing and learning about motion through working together and brainstorming a solution by skyping with an engineer in California to create a tool to solve the problem. The students presented a prototype to the Board.

Michael Lehmann, a community member, former Center Street parent and retired Veteran, shared his appreciation of the annual Veteran's Day Celebration by presenting Principal Patti Sotero with a plaque. Michael gave an overview of the annual celebration and how it grows every year. He stated the emotion you feel as you walk through the halls is overwhelming and you will see more than one adult and Veteran with tears in their eyes. He stated it is a beautiful thing and believes that Center Street is the only school who does this and doesn't know who enjoys it more the staff, students or the Veterans.

Principal Patti Sotero stated the presentation that you seen tonight are some of the many ways that we partner to instill in our students a lifetime of learning. Patti stated it would not be possible without our dedicated staff who go above and beyond on a daily basis. Our PTO provides not only hands-on support, but also financial resources and many behind-the-scenes support which makes our programs and activities successful. Patti thanked the parents, staff, Board Members and Dr. Marino for helping to make Center Street Elementary School successful.

Board President Brian Lynch thanked Principal Patti Sotero, the Staff, Student Council Members and the PTO for presenting an amazing presentation. Brian stated it is amazing to see what this school accomplishes on a yearly basis. Every year when the Board returns there is always a new activity/event for the students. It is remarkable that this is possible but yet it continues. The School Council partnering with the PTO to tie into the Red Cross is a

neat idea. The various Clubs including learning Sign Language at such a young age is very impressive. The incorporation of skydiving with an engineer in California and working together to solve a real-life problem through the use of the FOSS Program is a great way to teach kids to work together to solve a problem. To see it from the initial steps to the prototype is very impressive. Once again, Brian thanked the PTO for their continual support and stated without the PTO Center Street could not do as much as it does for the students.

Board Member Karen Boulas thanked Center Street Principal Patti Sotero and the staff for focusing the students' curriculum on becoming life-long learners at such a young age.

Board Member Warren Conklin stated he really enjoyed the government portion of the presentation. Government is such an important part of our lives and maybe someday we will see one of these students leading our community or on the Board of Education.

Board Member Jim Jacobus thanked Principal Patti Sotero and the staff for sharing with us during our Board Tour some of the things that the staff does for students who really need that extra "personal touch". Jim stated these are the things that he hopes everyone in the public realizes that far exceeds the responsibility of just teaching academics. Furthermore, Jim stated he believes that people have very little clue of how teachers really go above and beyond the call of duty on a daily basis.

#### **Report From New BOCES Superintendent**

Superintendent Dr. Ralph Marino introduced Jim Frame, the new District Superintendent for the Greater Southern Tier BOCES, to the Board. Jim stated prior to the BOCES position, he was Superintendent in the Odessa-Montour District and stated that his goal is to re-introduce BOCES to the Horseheads District. Jim stated that BOCES has a great relationship with Horseheads and he intends to work more directly with the Board to partner with the District to ensure the program is what Horseheads needs and is as effective as it could be. Jim stated he has a great working relationship with Dr. Marino and the Board has excellent representation on the Board who include Rose Apgar and Doug Johnson.

#### **District-Wide Technology and Security Improvements**

Superintendent Dr. Ralph Marino stated that almost two years ago the District had a Study done focusing on District Technology and Security. Jeff Robbins and Ryan Garrison from Hunt Engineers, Architects, and Land Surveyors updated the Board on the status of the security and technology improvements. They shared information on several phases of the project. The Board decided to consider Phase 1, improvements using the Smart Schools Bond Act money approved by State voters in December, and Phase 2, which will require public approval. The District currently has funds set aside to pay for this phase of the project. This phase of the project will be offered to voters at the May 19<sup>th</sup> budget vote/school board election. Board President Brian Lynch stated the Finance Committee reviewed this at their last meeting and will review this again with the Board as more information becomes available before the March 15<sup>th</sup> deadline. There weren't any reservations from the Board members.

Ryan Garrison reviewed the Scope of the original project stating demands have changed. The District's network is adapting to more devices such as voice, data and computer-based testing. Ryan reviewed the Technology Scope including Data Room Renovations, Robust Network, Network Electronic Upgrade, 100% Wireless Coverage, Office and Classroom Data Cabling Replacement and VOIP Phone System, Security and Ceiling and Lighting Replacement, IPTV-On Demand Educational Videos. The 2012 Study was reviewed noting \$12 million was estimated to complete District-Wide IP Security Camera Equipment, Secured Entrances, Intruder Locksets and Network Equipment. The Smart Schools Bond Act was reviewed noting \$2.9 million allocation awarded to the Horseheads Central School District.

Ryan Garrison reviewed the next steps which consist of Phase 1 - \$2.9 million on Smart Schools Bond Act will occur once the process is defined by the State. Phase 2- \$2.4 million will be voted for approval on May 19, 2015, as a Public Referendum for construction in 2016. Phases 3-5 will be future public referendums which will provide the District with time to determine elementary school technology plan based on the District's building decisions.

Ryan Garrison the Project Incidentals Budget which consists of Lawyer Fees, Construction Manager Fees, Testing Costs, Architect and Engineering Fees, Bid Advertisement, Printing Costs Insurance and General Administration Costs. Additional Savings Opportunities include NYSEROA Grant, Vendor Equipment Trade-Ins, E-Rate and Annual Power Savings from LED Lighting.

Board Member Doug Johnson inquired if approval is still needed for Phase 2. Superintendent Dr. Ralph Marino stated, "yes," designs will be submitted around Christmas so that the vote can occur in May. Ralph noted there will be some type of building process which will have to be presented to the State.

Board Member Karen Boulas inquired if there was a Plan B if the Smart Schools Bond Act did not pass. Ralph stated this was done after it passed so when the money becomes available the process will start.

Board Member Warren Conklin inquired where will the 10Gbps take us and how long will it be usable. Mr. Garrison stated the Robust Network will support any path to one-on-one learning that the District takes in the future as the infrastructure will be in place.

Superintendent Dr. Ralph Marino stated Phase 2 includes the full Intermediate/Middle School Complex which we will have to pay for; however, we will not have to borrow money as we already have it set aside which is to our advantage when it goes to Public Referendum. Ralph stated we are looking for feedback from the Board as we need to have approval for all the propositions for the Ballot in May.

### **Report From The Superintendent**

#### **Update on the Facility Capacity/Utilization and Grade Configuration Task Force**

Superintendent Dr. Ralph Marino updated the Board on the Facility Capacity/Utilization and Grade Configuration Task Force noting to date five meetings have been held and stated the Task Force is proceeding very well with great attendance and members working very hard. To date three of the six options have been reviewed and the Task Force is on target to complete their preliminary statements by the end of March per the Board's deadline.

#### **Update on the Consolidation/Feasibility Study with Elmira Heights Central School District**

Superintendent Dr. Ralph Marino presented the Board with an update on the Feasibility/Consolidation Study with Elmira Heights Central School District. Ralph stated the Task is going well according to the timeline. Ralph stated a meeting was held this past Monday with all information available on the WebSite. Ralph strongly recommends people view this as it contains a tremendous amount of data on both Districts and a lot of people are giving up their time to work together with the consultants on this Task. Ralph stated that the Study is on target to be completed in May, the Board will receive recommendations in June which will then be sent to the State.

#### **2015-2016 Budget Planning and Development Process**

Superintendent Dr. Ralph Marino reported on the development of the 2015-2016 School Budget Planning and Development Process, stating that the Board's Finance Committee will hold two Community Budget Input Sessions in January and three Community Budget Workshops will be held in February, March and April. Ralph also stated all budget documents will be on the District website.

Board Member Karen Boulas stated she feels that the Board would benefit from Mr. Little’s knowledge if he were to come and present to us as he could help us to become more uniformed.
