Agenda Changes

Board President Pam Strollo welcomed everyone to tonight's meeting and extended a special thank you to Center Street Elementary School Principal Mrs. Patty Sotero and the staff and families of Center Street Elementary School. Pam stated visiting the schools of our District is one of the highlights of the year for the Board. Pam stated Agenda Item 9.14 – Resolution Awarding Field House Project Bid will be tabled until the March Meeting, there will be an addition of Agenda Item 9.19 - Approval of the Disposal of District Property and Executive Session will be held directly after the Board Meeting to discuss CSE/CPSE/504 Recommendations.

Community Questions and Comments

Board President Pam Strollo explained the procedures for the Questions and Comments Section for those who are new at tonight's meeting. There were no Questions or Comments from the community.

Student Representative Report

Board Student Representative Matthew Minor reported on various events and activities at the High School, including the District Concert on March 1st, start of the Spring Sports Season on March 6th, Horseheads St. Patrick's Day Parade on March 11th, Report Cards and Parents' Night on March 15th, special Harmony Bridge performance at Elderwood in Waverly on March 16th and the Greenroom Players' production of 'The Addams Family' March 23rd-25th.

Presentations

Center Street Elementary School Presentation: "Partners For Student Success"
Center Street Elementary School Student Council members welcomed the Board and public to Center Street Elementary School's Presentation: "Partners For Student Success." The

presentation focused on how the school is expanding students' experiences through global partnerships and school support throughout the community such as partnering with the SPCA and the Red Cross. School Secretary Kathy Wigsten described the Veterans Tribute which is held annually.

Teachers Lorraine Packard, Kelli French, Stacey Finnerty, Tonia Prutsman, and Elisabeth Blasic reported that their students are corresponding and connecting to students in Haiti, Madrid, Mexico City, France, and Nevada as Pen Pals through writing and Google connections. Kelli also stated that she is currently working on a partnership with a school in Australia. Anna Fuksman described the Newspaper Club's new connection with students in Ukraine. They stated that these partnerships gives the students more enthusiasm to produce a better piece and understanding of writing and also enriches the lives of the students beyond the textbook.

Kim Balliet reported that Pre-Kindergartners have visited residents at Appleridge and Bethany, where beloved volunteer Lesley Barfoot now resides. Parent and Student Council Advisor Michelle Gryska described how the group is serving our community through partnering with the American Red Cross Pint-Sized Hero Program and stated that on March 10th, the Red Cross will honor the young group with the Good Samaritan Youth Award. The students also have a Reading Partnership with the Jackals.

PTO Co-President Melissa Yearick also described how the Parent Group is supporting their school, teachers and staff, and students. Melissa described various activities and events the PTO sponsors such as the Carnival and Family Fun Nights and stated monies that the PTO raises goes back into Center Street Elementary School to make learning more successful.

Reading Specialists Cara Wijkowski and Patty Howe described the Response to Intervention Program for English Language Arts and Math and how it supports students' learning. They stated the school has created individual, specific goals for every student receiving remedial support and how they start with two challenges and celebrate those successes.

Principal Patty Sotero concluded the Presentation by thanking staff for the unity they've created throughout the school and stated that the role modeling never ends. Every child counts and makes a difference no matter their age and the positive partnerships help us to be more successful.

Board Members shared their appreciation for the work students and staff are doing at Center Street Elementary School. President Pam Strollo commented on a term the principal used, saying it's a perfect description, "a caring community of learners". The Board thanked the entire staff and school for participating in the Global Partnerships, acknowledged the staff for their focus on good citizenship and congratulated them for all their endeavors.

Preliminary 2017-2018 School Budget Presentation:

School Business Administrator Katy Buzzetti updated the Board on the development of the 2017-2018 Budget. Katy stated the current Budget Gap is \$5.2 million and does not include any additional State Aid that the District may receive, use of the Fund Balance or Reserve Funds, or Reductions. Katy stated the next Budget Presentation will be held on March 9th at the Erin Town Hall at 6:00 PM and will include Preliminary Budgets for Special Education and Athletic Programs and Benefits.

Human Resources Overview

Director of Human Resources Judy Christiansen presented an overview of the Preliminary Human Resources Budget for 2017-2018, noting it totals \$407,225, an increase of 5.23%. Judy noted the biggest part of the Budget is Salaries.

Operations And Maintenance Overview

Director of Facilities Michael Coghlan presented an overview of the Preliminary Facilities Budget for 2017-2018, noting it totals \$3,615,888, an increase of 1.62%. Mike stated that presently Facilities struggles with having 1.5 cleaners working nights and are about 20% down from where our numbers were before the Recession. He stated as we move forward with our Capital work it will put a strain on us. We are making it work with the current staff we have, but it could always get better.

Technology Overview

Director of Technology Gregg Moyer presented an overview of the Preliminary Technology Budget for 2017-2018, noting it totals \$2,522,972, an increase of 2.24%. Gregg noted that the Supplies have been increased to prevent fewer Transfer Requests and there has also been an increase in the BOCES category which includes the Director of Technology, Network Technicians and Instructional Support Specialists. Gregg stated that the Summer Help has increased for two people to work 35 hours a week for 8 weeks to hep get our rooms back in shape and will be money that will be very well spent.

Superintendent Report

Superintendent Report

Superintendent of Schools Dr. Thomas J. Douglas congratulated student-athletes on a great winter season and wished those headed to post-season play the best of luck. Dr. Douglas also informed the Board that he approved two Overnight Field Trips for the Teams today.

Dr. Douglas also reminded the Board and audience of the first full Community Input Session for the Horseheads 2030 Infrastructure discussion will be held on Tuesday, February 28th at 7:00 PM in the High School Auditorium. He stated this and all meetings regarding Infrastructure are open to the public. Dr. Douglas thanked the Board for taking time out of their daily schedule to visit the schools last week and noted that he will be sending a note to staff thanking them as well. He updated the Board on a meeting with HUNT Engineers and Architects earlier today in which they discussed the timing of the Horseheads 2030 Capital Projects.

Dr. Douglas asked the Board to consider a Tentative Referendum Vote that will take place sometime in October. He reviewed the three plans that HUNT prepared which will keep our finances down. Dr. Douglas stated we are going to build the best possible package where we utilize all of our financial resources while trying to accomplish everything the Board has asked us to do in the Scope. Some of the work includes addressing the traffic flow at the Middle/Intermediate School Complex, technology component at the schools, classroom and playground upgrades and roof maintenance.

Dr. Douglas also noted that the paperless meeting software, BoardDocs, is currently in use and the Board will be transitioning to paperless in the next few meetings.

Assistant Superintendent Tony Gill presented an overview of the Horseheads 2030 Education Committee and its progress, noting that the educational discussion will drive the infrastructure process. He stated a small group met earlier today to look at the applications for the Committee. Tony presented an overview of the work with the Facilitator who will guide the process.
