# **Agenda Changes**

Board President Pam Strollo stated we are happy to be here at the High School for our first school visit of the school year. Pam explained the procedures for the Questions and Comments Section for those who are new at tonight's meeting. Pam stated the Board received an updated Agenda Item 9.19 – Resolution To Approve Settlement For Anschutz Exploration Corporation Application For Refund Of Real Property Taxes for 2014-2015 and stated there will be an Executive Session directly after the Board Meeting to discuss CSE/CPSE/504 Recommendations.

There were no questions or comments from the Community.

# **Student Representative Report**

Student Representative Matthew Minor reported on the opening month of school. Activities included Freshman First Day, which he described as well-planned and organized, Parents' Night, Spirit Week, the Pep Rally, and Homecoming. He also reported on upcoming dates including the Class Officer Induction October 3<sup>rd</sup>, end of marking period October 5<sup>th</sup>, Report Cards and Parents' Night October 19<sup>th</sup>, and College Information Day October 20<sup>th</sup>. He informed the Board that Student Council sold 9/11 pins in order to raise funds to buy a brick at the 9/11 Memorial. Matt reported on the sports and marching band seasons, and said that the first month of school has "started off with a bang," noting that student morale and attitudes seem to have improved. Board President Pam Strollo thanked Matt for presenting a very comprehensive report.

## **Presentations**

## **High School Presentation – "Horseheads 2016)**

High School Principal Karen Donahue began the Presentation, "Horseheads 2016," by introducing the New Administrative Team to the Board and thanked the Board for restoring a full Administrative Team at the High School and noted that the Freshman Class is the Class of 2020.

Assistant Principal Dan Buseck reported on Freshman First Day, noting that the day is much more student-organized than when first introduced when it was teacher driven. It has progressed to the point where the Seniors have become more and more involved. The day involves three parts: a tour of the High School, skits and activities and concludes with an informational session in the Library.

Assistant Principal Mike McCawley reported on the Dignity for All Students Act presentations the Freshmen heard on the first day which focused on the culture and climate of the building and the Character Education Program including posters and bulletin boards throughout the building that are dedicated to each trait and the Student of the Month. The presentations which align with the District Character Education Program were recorded and shared with all the students the first week of school.

High School Principal Karen Donahue spoke about the many volunteer activities staff(who already have a specific position in the school) have taken on including several bulletin boards throughout the building, the Student of the Month Program, Hallway of Heroes, and more. Karen also spoke about culture and climate, showing photos of Spirit Week and the Pep Rally. She stated that volunteerism is very high at the High School not only with adults but also with students such as those who participate in Harmony Bridge which makes the High School a great place to be.

Assistant Principal Kris Earl spoke about new instructional programs offered at the High School this year, including the P-Tech program, a six-year regional program. Students will end the six years with an Associate's Degree. Six Horseheads students currently attend the Program with about seventy-five other who have expressed an interest. Kris also reported on the new Forensic Science course, with two sections this semester.

Board President Pam Strollo thanked the High School for a great presentation. Pam stated that Freshmen First Day is a great introduction to the High School for the in-coming students and using the students who have already gone through it is really a big deal. She stated it is wonderful that people are empowering themselves to volunteer throughout the building making bulletin boards, displays, etc. and the interaction the staff has with the students is so vitally important.

Board Member Karen Boulas thanked the High School administrators and staff for their dedication to the High School community through volunteerism and the initiative to keep it strong as obtaining volunteers is not an easy thing to do.

Board Vice-President Brian Lynch stated he is very impressed with Freshmen First Day and the Character Education Program and how strong of a component it is at the High School as what the students learn they will take with them later in life.

## 2015-2016 External Audit(Tom Zuber from Raymond F. Wager, CPA, P.C.)

Tom Zuber, CPA, of Raymond and Wagner presented the 2015-2016 District's External Audit for the year ending June 30, 2016. He noted that there have been many stories in the media about District Audits, and that his firm has a fundamental disagreement with the State in terms of long-term planning. The firm feels Reserves and long-term planning are very important to the future of Districts, while the State has been commenting that Districts should reduce their Reserves. Tom reported that the District continues to be in good financial conditions, but there are challenges that all Districts face, including State Aid uncertainty, Property Tax Cap, and the rising costs of employee benefits. He stated the District is doing an excellent job of funding

its Reserves and reducing reliance on the Fund Balance as part of a long-term plan. The internal control portion of the Audit showed no significant deficiencies or material weaknesses and only minor procedural recommendations. It also stated that prior year recommendations have been implemented to the auditor's satisfaction. The Single Audit portion looked at federal awards, noting that the District is a low risk auditee and including no audit findings. The Audit also included student activity funds, recommending that the District continue to monitor for student participation and use of gift cards.

# Superintendent Report

# Superintendent Report

Superintendent of Schools Dr. Thomas J. Douglas thanked the Facilities Staff for readying the District for the opening of the school year, and thanked everyone in the District for a great opening of school. He congratulated the Marching Band on a great opening to their competition season and for being ambassadors of the District. He also congratulated the eight Seniors who are Commended Students in the National Merit Scholarship Program: Henry Farr, Omair Irfan, Nick Juan, Sam Kuhnel, Alex Lee, Jiesi Liu, Dominic Magistro, and Ken Peterson.

Dr. Douglas noted that October will include three Special Board Meetings as part of the Horseheads 2030 Project. The meetings will be for interviews for architectural services. In November-December, the District will follow up with securing construction management services because of the large scope of the project. A Construction Manager will help guide the District through the infrastructure side of the project. He also presented a draft of the Horseheads 2030 Communication Plan and stated if the Board thinks of any potential issues to let him know so that he is able to put it in the Draft.

Dr. Douglas also reported on the continuing implementation of the new Transportation Policy for athletic contests and stated it applies to all sports seasons this year. Director of Physical Education and Athletics Bert Conklin noted that some requests are being denied due to lack of detail, however, if there is a legitimate reason those submitted are being approved. He stated it has been challenging and is being as fairly applied as possible. Bert commended the parents for submitting requests in a timely manner.

Dr. Douglas reported on the current approval process being followed for a new Compressor Station in Sullivanville. The District has not received any notices or information on the Project and stressed that area residents have expressed their concerns to the town, but noted that officials have said there is little recourse once the federal government decides a project is important to the economy.
